

General Terms and Conditions – Finder Flash Sale Promotion

1. Introduction:

- i. The following terms apply, for a limited period, between all participants and World First PTY Limited (“World First”) in conjunction with this offer proposed by WorldFirst to provide new customers with a free AUD\$100 account credit (the “Credit”).
- ii. By accepting this offer, you are agreeing to these General Terms and Conditions.

2. The Offer:

- i. This offer is available to new WorldFirst customers only.
